Pursuant to the provisions of Article 25 of the Company Agreement for Pula Airport Ltd., Articles 2 and 5 of the Law on Airports (Official Gazette No. 19/98, 14/11 and 78/15), the company's Board member Nina Vojnić Žagar on June 28, 2023 has issued the following

I. AMENDMENTS TO THE GENERAL CONDITIONS ON THE USE OF PARKING AREAS AT PULA AIRPORT Ltd.

Article 1

It is established that the General Terms and Conditions on the use of parking areas at Pula Airport Ltd. (Class: 2023/247, Reg.No.: 2023-01-1) adopted on June 15, 2023, were published on the Company's website on the same day and that they entered into force on the same day.

These Amendments change the General Terms and Conditions for the use of parking areas at Pula Airport Ltd. from paragraph 1 of this article.

Article 2

Paragraph 2 of Article 3 is amended to read:

By parking the vehicle in the Parking lots, the owner of the vehicle stipulates a contract with Pula Airport Ltd. on the use of the parking subject to payment with the use of a daily parking ticket and on accepting these General Terms and Conditions.

Article 3

Paragraph 4 is added to Article 8, and reads:

Taxi carriers whose purchased parking card has been deactivated due to non-compliance with the General Terms and Conditions from the previous paragraph do not have the right to use the parking areas.

Article 4

Article 9 is amended to read:

The following categories of legal and physical persons have the right of access and parking at Parking B – Short term:

- users of official vehicles of Pula Airport Ltd., Ministry of Internal Affairs, Ministry of Finance - Customs Administration, Croatian Air Navigation Control, Securitas Hrvatska d.o.o. and business partners in designated and marked places with a previously obtained permit from Pula Airport Ltd.



- rent a car vehicles, in accordance with the previously stipulated contact on the rental of parking spaces in designated lots,
- users of annual parking cards for Taxi transportation,
- providers of transfer services with a previously purchased monthly ticket,
- emergency service vehicles,
- vehicles used for the transport, boarding and disembarking of passengers with special needs at specifically marked areas.
- vehicles of users who have been granted VIP status.

Article 5

Access to Parking B - Short term is possible for up to 10 minutes at specifically marked places exclusively for exiting passengers (taxi transport, transfer, kiss and fly).

Article 6

Article 11 is amended to read:

All legal and physical persons have the right to access and park at Parking A - Long term, subject to payment.

Taxi carriers who are not users of an annual parking card and/or passenger transfer service providers who have not purchased a monthly ticket for access to Parking B - Short term, are obliged to unload or pick up passengers at specifically designated Meet and Greet lots - 35 parking spaces.

In the event that all the parking spaces from the previous paragraph are occupied, the users from the previous paragraph can use other free spaces in Parking A for the aforementioned services.

The aforementioned carriers are not allowed to pick up passengers from the area of Pula Airport unless the ride has been pre-ordered/contracted.

Article 7

Article 13 is amended to read:

A user who uses the Parking contrary to these General Terms and Conditions or provides other services (Taxi transportation, i.e. occasional transportation (transfer), and does not act in accordance with these General Terms and Conditions, shall be verbally warned by the authorized person - the security guard that such behaviour is prohibited, ordered to stop such behaviour and instructed to leave Pula Airport if the user continues to behave contrary to these General Terms and Conditions.

Decision on fees for parking services in the area of Pula Airport Ltd. (CLASS: 2023/01, REG.NO.: 2023-01-144) as of June 28, 2023) applies to these General Terms and Conditions.

For each use of the Parking contrary to the General Conditions, a fee in the amount of EUR 150.00 (HRK 1,130.18*) is payable, in accordance with Article 6 of the Decision on fees for parking services in the area of Pula Airport Ltd. (CLASS: 2023/01, REG.NO.: 2023-01-144) as of June 1285, 2023.

Proceedings according to paragraph 1 of this article do not exclude the application of the Decision on fees for parking services in the area of Pula Airport.



Article 8

Ove Izmjene i dopune Općih uvjeta stupaju na snagu 1. srpnja 2023. godine. These amendments to the General Terms and Conditions enter into force on July 1, 2023.
