Pursuant to the provisions of Article 25 of the Company Agreement for Pula Airport Ltd., the company's Board member Nina Vojnić Žagar on March 20, 2026 has issued the following

DECISION ON FEES FOR PARKING SERVICES IN THE AREA OF PULA AIRPORT

Article 1

Fees for parking services in the area of Parking A - Long term for physical persons and business entities amount to:

a) For the period November 1 – March 31

HOURS	FEE	LOST CARD
The fee is calculated per each started hour	0,50 EUR / hour	111,00 EUR
For parking longer than 24 hours, a fee is charged per day of use of the parking lot	3,00 EUR/ day	

b) For the period April 1 – October 31

HOURS	FEE	LOST CARD
For the first 4 hours of parking - the fee is calculated per each started hour	3,00 EUR / hour	240,00 EUR
For parking longer than 4 hours	0,50 EUR / hour	

The fee is paid at the price valid on the day of departure.

Note: VAT is included in the listed prices.
The first 10 minutes are free of charge.
No daily tickets available.

A day in the sense of this Decision represents 24 hours from entering the parking lot and the time indicated on the parking ticket, and each subsequent day is the next 24-hour period that begins with the expiration of the previous 24 hours.

Article 2

Fees for an annual parking card for parking one vehicle in the area of Parking A – Long term for individuals and legal entities is EUR 310,00 including value added tax. The fee is paid in advance for a period of one year.

Article 3

Fees for parking services in the area of Parking B – Short term for business entities carriers (transfers and VIP users) amount to:

a) For the period November 1 – March 31

b) For the period April 1 – October 31

Transfer/ VIP user	208,00 EUR per card and vehicle	1- 3 parking cards
	166,00 EUR per card and vehicle	4 - 10 parking cards
	125,00 EUR per card and vehicle	11 and more parking cards

The fee at the stated rate is charged for the entire period, regardless of the duration of use.

c) The daily fee for the entry of one vehicle amounts to:

For the period November 1 – March 31: 10,00 EUR per entry

For the period April 1 – October 31: 15,00 EUR per entry

Service fees are exclusively payable in advance accompanied by a special contract concluded with Pula Airport. After entering parking lot B, the specified service cannot be requested.

The fee under c) is announced to the sales department by email to commercial@airport-pula.hr.

Pula Airport Ltd. reserves the right to review the grounds for providing the transfer service.

Fees for parking services in the area of Parking B – Short term for rent a car operators amount to:

Note: VAT is not included in the listed prices. A contract is concluded for the lease of parking spaces and the fee is paid in accordance with the agreed conditions.	
Fee for each vehicle after exceeding the leased number of parking spaces	50,00 EUR per vehicle

Article 5

The Fee for access to the area of Parking B – Short term for Taxi vehicles by authorized Taxi transportation service providers for the period June 1, 2026 - May 31, 2027. amounts to 2,076.00 EUR per issued card. The number of issued annual cards at a preferential price is limited to 40, and they are issued based on a published public call. VAT is included in the listed prices.

Article 6

Persons with disabilities, as well as users transporting PRM passengers (persons with reduced mobility), are entitled to exemption from parking fees, subject to the following conditions:

- The vehicle must display a valid parking permit for persons with disabilities (EU badge) in a visible place.

- The exemption applies exclusively in cases of actual transport of PRM passengers (arrival or departure of a person with reduced mobility).
- Upon request by an authorized person, the user must provide proof of PRM passenger status or the purpose of transport.
- The exemption applies only for the time necessary for passenger drop-off or pick-up, is valid in Parking Area A and Parking Area B, is limited to a maximum of 10 minutes from vehicle entry, and cannot be used for long-term parking.

Article 7

For the use of parking areas, all users are obliged to comply with the valid General Terms and Conditions on the use of parking areas at Pula Airport Ltd. published on the Internet pages.

A fee of EUR 50.00 is payable for each use of the Parking contrary to the General Terms and Conditions.

Article 8

All special services provided by legal and physical persons to airport users are governed by a contract with Pula Airport Ltd.

Article 9

This Decision enters into force and applies starting from May 1, 2026. With the entry into force of this decision, previously adopted decisions on fees for parking services cease to be valid.
